

BOMBAY PROHIBITION ACT, 1949.

No. 9987/49(c).—In exercise of the powers conferred by section 6 of the Bombay Prohibition Act, 1949 (Bom. XXV of 1949), and of all other powers enabling it in this behalf, the Government of Bombay is pleased to amend the Government Notification in the Revenue Department, No. 10484/45(s), dated the 16th June 1949, as follows, namely :—

In Schedule A appended to the said notification—

(1) In column 3, against Serial No. 1, in entry (ii) after the word "sections" the figures "52" shall be inserted ;

(2) In column 3 against Serial No. 8A, after entry (a) the following new entry shall be inserted, namely :—

" (b) Power under section 52 to grant permits for possession and use of hemp drugs or opium ", ;

(3) In column 3, against Serial No. 14, in entry (ii) for the figures, brackets and word "46(1) and 48" the figures, brackets and word "46(1), 48 and 52" shall be substituted.

BOMBAY PREVENTION OF FRAGMENTATION AND CONSOLIDATION OF HOLDINGS Act, 1947.

No. 5869/45.—In exercise of the powers conferred by sub-section (2) of section 4 of the Bombay Prevention of Fragmentation and Consolidation of Holdings Act, 1947 (Bom. LXII of 1947), the Government of Bombay is pleased—

(i) to publish the area specified in column 3 of the Schedule annexed hereto as the minimum area which the Government of Bombay has provisionally settled under sub-section (1) of the said section 4, for the class of land specified in column 2 thereof in the local area or areas specified in column 1 thereof ; and

(ii) to invite objections thereto, which shall be forwarded to the Secretary to Government, Revenue Department.
