BOMBAY AGRICULTURAL PRODUCE MARKETS ACT, 1939.

No. PMC. 1060/18842-G(1).—In exercise of the powers conferred by sections 5 and 7 of the Bombay Agricultural Produce Markets Act, 1939 (Bom. XXII of 1939), the Government of Maharashtra hereby—
