BOMBAY PREVENTION OF FRAGMENTATION AND CONSOLIDATION OF HOLDINGS ACT, 1947.

BOMBAY MONEY-LENDERS ACT, 1946.

No. MLA. 1060/14660-G.—In exercise of the powers conferred by section 39 of the Bombay Money-lenders Act, 1946 (Bom. XXXI of 1947), the Government of Maharashtra hereby amends the Bombay Money-lenders Rules, 1959, as follows, namely :—

In the said rules,—

(1) in Forms Nos. 5 and 6, appended thereto, for the words "Creditor" and "Debtor", the words "Credit" and "Debit", shall respectively be substituted ;
